 - II. Degree Course in Engineering of a recognized institute/College affiliated to a recognized University.
 - III. Doctors or equivalent (MBBS, MD or equivalent)
 - IV. other educational qualification which in the opinion of the managing council is at par or equivalent to the above qualification.
- 2. Inviting application/issue or receipt of application form is not the commitment of above fund to provide/sanction of the financial assistance applied for.
- 3. The Fund can make any enquiry in connection with the application received in such manner and from any person it deem desirable.
- 4. The application will be considered by the fund subject to availability of financial resources at its disposal.
- 5. In the case of delay of scholarship or non-remittance of scholarship, the trust shall not be liable for any losses incurred by the applicant or any consciences faced by the applicant.
