Rules & Regulation of Financial Assistance for Higher Education

1. Financial assistance will be provided for the following professional course :-
 - I. Masters Degree in Business Administration & Management.
 - II. Degree Course in Engineering of a recognized institute/College affiliated to a recognized University.
 - III. Doctors or equivalent (MBBS, MD or equivalent)
 - IV. other educational qualification which in the opinion of the managing council is at par or equivalent to the above qualification.
2. Inviting application/issue or receipt of application form is not the commitment of above fund to provide/sanction of the financial assistance applied for.
3. The Fund can make any enquiry in connection with the application received in such manner and from any person it deem desirable.
4. The application will be considered by the fund subject to availability of financial resources at its disposal.
5. In the case of delay of scholarship or non-remittance of scholarship, the trust shall not be liable for any losses incurred by the applicant or any consciences faced by the applicant.
6. I undertake to repay the Financial assistance provided by the fund back to the fund, free of interest so that the fund can run smoothly and help more students in future. I will pay this amount within five years of completion of my professional course or as within the limit, as may be extended by the Fund.
7. The applicant should provide all the information truly and correctly.
8. During the continuation of financial assistance if any details provided by the applicant are found to be untrue, the financial assistance will be discontinued forthwith and financial assistance availed by the applicant till then will be returnable immediately to the fund.
9. The application made for financial assistance may be cancelled/rejected by the fund without assigning any reason.
10. During the continuation of financial assistance the applicant will provide details of his half yearly academic progress regularly to the fund.
11. Decision of the fund in connection with application of financial assistance will be final and binding.
12. The details of financial assistance provided to an applicant may be circulated/published by the association at its discretion.
13. All the disputes relating to the issues covered by the application incidental thereto shall be referred to the sole arbitrator who will be Shree Khandelwal Vaish Mahasabha, Jaipur
